I. Janet called the meeting to order at 6:01 p.m. Roll was taken by written confirmation and a quorum was established. Janet introduced guests Missy Smith, Debbie Thomas and Ted Webber

II. Minutes – Minutes from the prior meeting were not circulated due to the unexpected resignation of former Executive Secretary, Beth Riggert.

III. Officer Reports

A. Treasurer – Margie Torkelson

 \Box The 2014 recorded a lost of approximately \$16000

- Revenue is drived by membership, shows and banquet
- Donations for scholarships are down but it was noted that the scholarship fund is a restricted fund – scholarship amounts are \$1000 for Saddleseat, \$500 each for Hunt and Stockseat
- 2014 saw in increase in liability insurance costs, website costs and extra expenditures for professional fees

 \Box There has been a drop in nominations. There was a brief discussion on the timing of the

April dressage show at William Woods University, and the possibility of getting WWU to nominate horses again.

2. Eventing -

□ Christy was unavailable and did not submit a report. Stacy Wright noted nothing is new to report.

 - □ Upcoming shows: Fancy Farms is adding a show; Cornerstone may or may do shows in 2015 Shows have started. Stacy has not switched to the new point system but will do so soon.
 - \Box Shows have started. Stacy will do a membership drive at the shows
- 4. Show horses & ponies Sue Webster

□ Concern was expressed about decreasing number of shows for SHP.

□ General Discussion, not limited strictly to SHP followed on the challenge to encourage nominations and membership in the face of the decline in shows; Janet challenge each member of the BOD to bring in 10 new members; JoJo raised the issue of getting individuals that ride but don't own a horse, and this issue, including the Opportunity Rider class was discussed

- □ Marjorie brought up the cost of Paypal and the convenience fee, with the amount we are currently charging not fully covering the cost of the service; raising the cost for items was considered, and Stacy agreed to do a comparison between various credit card type services and report to the Board at the next meeting.
